Caspian Coffee is a coffee roasting company based in Messina Italy, that specializes in providing single origin coffee beans, ground coffee, and espresso capsules.

Caspian coffee plans to reduce their Green House Gas emissions by %40 with purchasing electricity with Guarantees of Origin Certificates. Also, during 2024 company plans to install solar power plant to roofs in their main premises and the roastery will undertake an insulation project in Messina plant.

Besides, company is looking options to produce bio-waste electricity from coffee wastes.

While implementing Caspian Green Program, starting from beginning of next year company plans to procure only Green House Gas mitigated packaging for the their GreenCoffee line.
